
NEW SERVICES: ANTI-TRAFFIKING WORKSHOPS

FCJ Refugee Centre and Downtown Legal Services organized an action -packed day of highly informative workshops.

Hosted at The Salvation Army's Harbour Light Centre on Jarvis Street, the day consisted of 10 presentations and question and answer sessions on a variety of topics to do with the Conservative government's overhaul of the Canadian refugee system. Experts, front line workers and students in the field of refugee protection led each session.

The day considered both the "big picture" context of the reforms made, addressed in Kristen Marshall's powerful opening remarks on the changing and the increasingly difficult situation refugees face in Canada, to very practical presentations.

The well-received morning sessions were led by Jennifer Bernardo, Jackie Chu, Carolyn Padget, and Rachel Bernhardt – students from Downtown Legal Services. They concisely outlined the most significant changes concerning PRRAs and Humanitarian and Compassionate Grounds applications in a clear

and informative manner. The case study examples they provided proved very popular and drove home the need for practical knowledge of the changes that have been made.

Throughout the day it became apparent to participants, most of whom were highly dedicated front-line workers, just how significant the scope of recent changes have been. Even what might seem like superficial or technical changes on the new basis of claim (BOC) forms that replace the Personal Information Form (PIF), were seen to have major repercussions for refugee claimants and how their claims would be perceived and subsequently adjudicated. Given this desperate need for up to date information, the FCJ's Giovanni Rico led a comprehensive session on completing the relevant forms for a refugee claim, while Franciso Rico-Martinez led a session on the dynamics of the IOM's "voluntary" return program.

John Norquay, the Staff Immigration Lawyer at HALCO: HIV and AIDS Legal Clinic outlined the drastic cuts to refugee health care due to the government's 2012 changes to the In-

terim Federal Health Program (IFHP), which until that time had remained relatively constant for over fifty years. He outlined what level of care is available to particular groups of claimants. Andrew Brouwer of the Refugee Law Office outlined the processes of Judicial Review and of the Refugee Appeal Division while stressing the need for quality legal representation.

From the presentations

it was seen to be crucial that front line workers have at least a general knowledge of these new processes, and the need for legal advice and assistance to those trying to navigate them. Fortunately, with around 200 participants in this workshop and the enthusiasm for such efforts to continue, the FCJ Refugee Centre, Downtown Legal Services, and their collaborators have made a strong contribution to these efforts.
